

The regular scheduled Candor Township meeting for **January 12, 2026** was called to order at 5:30 pm by Chairman Brad Syltie in Candor Town hall.

Present were Brad Syltie, Lowell Bradbury, Bruce Moe, Ryan Hansen, and Sharon Sauer. Visitors were Kelly Shannon, David Wightman, Duane Fillipi, Sandy and Steve Wendt, Jon Jeffery of Three Pines Tree Service and Torey Sonnenberg of Sonnenberg Excavating.

Minutes for the regular December meeting were approved with a motion from Lowell and a second from Brad. The treasures report was approved with a motion from Brad and second from Lowell. Unanimous vote on both motions.

Jon Jeffery came to the meeting to introduce Three Pines Tree Service. Their business cuts down trees and removes the wood if requested to do so. They charge \$350.00 per hour for four guys. They have a contract with Burlington township to remove trees when needed.

Torey from Sonnenberg Excavating was looking to extend his contract for grading and snow removal with Candor Township for 3 years, with a base rate of \$157/hour. Brad made a motion to extend the contract for three years which was seconded by Lowell.

Torey asked how his employee was doing snowplowing Candor roads. The Supervisors thought he was doing a better job of snow removal this year. Torey said he has done more sanding this year than most years.

The supervisors talked about the changes he would make to the Hobart Township tarring policy to make it conform to what Candor Township would like. Brad will try to have it typed up for next months meeting.

Bruce stated that road prep would have to be done to any road that is to be tarred as there are many rocks in Candor. Rocks will come through the road whether or not it is tarred.

Kelly Shannon complemented the board for keeping the roads in good condition. He is not in favor of tarring any road.

Ryan stated he saw 2 cars parked on Leek Lake Road around Christmas. The drivers were ice fishing. Someone else stated 3 cars were parked on Tee Lake Road, the drivers likewise were ice fishing.

Arvig inquired whether Candor would like internet service to the hall. After discussion it was decided to pass on internet service to the hall.

MN Multimedia, Kyle Meacham will need to build Candor Township a new website because Big Groovy owns the domain. Brad said he really liked Hobart Township's website.

Brad Syltie filed for the office of Supervisor and Sharon has asked someone to take the clerks office. She will contact her tomorrow. The township election will be March 10, 2026.

The Absentee Ballot board for the Annual Township Election to be held March 10, 2026, will be Bruce, Sharon and Lowell.

The January claims list was approved with a vote of 3 – 0.

Brad made a motion to adjourn the meeting at 7:05 pm which was seconded by Lowell. Unanimous decision.
